01 ADDRESS LABELS

A correctly completed and affixed address label is a key element in the shipment handling process. It allows for efficient collection of the shipment, registration, sorting and correct delivery. It is also an element marking the shipment, which in the event of any problems with its handling, will allow it to be identified.



1.

Place the label on the top surface of the package. Avoid sticking it on the seam (closure) of the package.

5.

In the case of poly mailers, make sure that the label is **stuck to an even surface** and that its fragments do not stick together.

2.

6.

Check the print quality of the label. Make sure it is not damaged and that parts of it have not been cut off. Print quality is especially important for barcodes.

Do not use glossy paper

to print labels.

З.

If you are using document enclosed labels – **do not use document enclosed labels with anything printed on them**, that can obscure the barcode or address data.

4.

In the case of a circular tube, stick the label along its longer axis.

7.

Remove all old address labels, tags and stickers, especially if the box has been used before.

8.

When using non-standard IT solutions, **the key to processing the shipment is the current directional information on the label** – the correct code of the delivering branch and the courier route.

SENDING PARCELS WITHOUT A LABEL IN THE INPOST MOBILE APP

1.

Ensure the Parcel Locker is properly secured and measure its dimensions. You can choose from three box siezes. Choose the one that your parcel's size - the information on page 6 can help you with this.

3.

Pay for your shipment: After completing the information, you will be redirected to a page where you can choose a payment method that is convenient for you. After completing the payment, a 9-digit shipping code and a QR code will appear in the application.

REMEMBER

You do not have to stick any label or place a tracking code on the parcel. However, if you want to place a code on the parcel, you can, of course do so.

2.

Select the SEND SHIPMENT option in the mobile app: choose the shipping method (you can send from a Parcel Locker machine to another Parcel Locker machine or from a Parcel Locker machine to a specified home or business address) and then fill in the required data for the recipient and sender. Your phone number will be filled in automatically.

4.

Send using a Parcel Locker: With your parcel ready, go to any Parcel Locker. In the Parcel Locker reader, scan the QR code from the app or on the Parcel Locker screen, select the option "I have a shipping code or return code" and enter the data. The locker will open automatically! Now put the parcel in the locker.





SENDING PARCELS WITHOUT LABELS -PRODUCT HANDLING FAST RETURNS

1.

Use the InPost Mobile app or go to https://szybkiezwroty.pl/en From the drop-down list, select the store where you purchased the goods to be returned.

4.

If you are returning the goods in their original packaging, remember to remove the original address label.

7.

Choose the correct locker size - remember that lockers have specific sizes:

A: 8 x 38 x 64 cm, B: 19 x 38 x 64 cm, C: 41 x 38 x 64 cm.

2.

Provide order details - fill out the return form. You can provide the order number, but you don't have to - it is helpful for the Seller, but not necessary. Fill out all fields carefully.

5.

Go to the Parcel Locker device on the device screen select "I want to send a parcel" and then "Enter code".

8.

Place the properly prepared and packed parcel into the locker - the locker in the selected size will open automatically. Place the parcel inside and close the door.

3.

Wait for confirmation - we will send you an email and SMS confirming your return.

6.

Please use the 10-digit returns code we sent to you when we approved your returns request.

9.

Make sure the process has been completed.

A package with any dimension exceeding 120 cm or the sum of its dimensions (length + width + height) exceeding 220 cm. A nonstandard package also includes: items with a round, cylindrical or oval shape, irregular shapes and/or with protruding elements.

02 PACKING SHIPMENTS



Choose the right box

The packaging should be selected to suit the characteristics of the product being transported. The cardboard should be of appropriate hardness and should not have any mechanical damage. Depending on the sensitivity of the product to damage and its weight, the appropriate thickness of the packaging should be chosen - for example, for packages weighing more than 5 kg, use cardboard made of at least two-layer cardboard (density of 375 g/m2), for packages over 20 kg, use three-layer cardboard (density of more than 427 g/m2).

How to check the quality of the packaging?

Press the top, side and edge of the box – if the box deforms or becomes damaged, the outer packaging is not suitable.



Fill the package

Use a material that fills the empty space inside the box. The purpose of the filling is to absorb external factors that affect the shipment and not transfer them to the product. Properly filling the package prevents damage due to crushing.

How to check the quality of the packaging?

Press the top, side and edge of the box – if the box deforms or becomes damaged, the outer packaging is not suitable.



Lock the product inside

The immobilization of the product is intended to prevent the contents from moving inside the package. A moving product may damage itself (e.g. against another product, packaging) or puncture the packaging and damage another shipment.

How to check the quality of the immobilization?

Lift and shake the package – if the contents move inside the package, they are not properly secured.



4.

Separate products inside

Separating products from each other eliminates the possibility of products damaging each other or damaging the packaging. Use this method of packaging when shipping multiple individual packages.

How to check the suitability of the packaging?

Lift and shake the package – if the contents move inside the package, the are not properly secured.

5.



Secure the product

In transport conditions, it is impossible to ensure a permanent position of the shipment, therefore all sides of the contents inside the package must be evenly secured and have a relatively stable position. It should be remembered that during the sorting and transport process, the shipment may be arranged in different ways - on each of the sides.

How to check the security of the product?

Press the top and two sides of the packaging - if the packed product can be felt through the packaging, it means that it is not secured on all sides and is in contact with the packaging.





InPost company packaging – cardboard envelope

The contents of the cardboard envelope cannot exceed 1 kg. It can contain documents, diskettes, CDs and other flat items, provided that they are secured inside the shipment with bubble wrap.

InPost company packaging – foil wrapper

The contents of the poly mailer should not exceed 2 kg, due to the standard level of strength of this type of packaging. It can be used to transport documents, small cardboard packages containing light goods that do not have sharp, angular shapes that could cause the packaging to be cut from the inside.

Circular Tube

A standard package is considered to be a tube up to 120 cm in length and 10 cm in diameter. A tube is an exception to the definition of a nonstandard package only if the conditions regarding its maximum dimensions are met.





Close and Seal

A properly closed and sealed package prevents the package from opening on its own and the loss of its contents. The method of properly closing and sealing the shipment - closing with the so-called double letter "H". Use tape with a width of at least 48 mm.

How to check if it is closed and sealed correctly?

Press the top and bottom of the package where it is sealed with adhesive tape - if the adhesive tape comes off the box, causing access to the contents, it means that the shipment is not properly closed and sealed.





The "cardboard in cardboard" method

Products from sensitive groups, including sharp objects, e.g. a knife or a penknife, should be packed using the "cardboard in cardboard" method - the space between the outer and inner cartons will additionally protect the goods. This method is also recommended for sending other goods that require special care during transport. Cosmetics in glass packaging packed using the "cardboard in cardboard" method should be additionally wrapped in bubble wrap/foam. The carton should be selected depending on the weight - two-layer cardboard with a density of 375 g/m2 (up to 5 kg) or with a density of 427 g/m2 (for weights above 5 kg).

Correct blade securing







It is permissible to secure the cardboard box from the outside with stretch foil. This type of packaging is not treated as a Non-Standard Package (if the other conditions are met, especially those concerning regular shapes, and the use of stretch foil, the structure of which does not stop the movement of the package on conveyor belts).

7.

Combining multiple unit packages into one package ("plywood")

In the InPost network it is prohibited to combine separate unit packages poly mailers, tubes and long items - into one parcel.

When combining two or more

one parcel, the recommended

separate unit packages into

packaging method is to use

an outer cardboard box.

A package created by combining two or more separate unit packages, in the case of packaging without an additional external cardboard box, should be secured against separation of the individual packages - the use of two layers of stretch foil and tape or binding tape is required.

In the event of shipping a parcel consisting of two or more separate unit packages within one parcel - without an external, additional box. the shipment will be classified as a non-standard parcel, which will result in charging a fee specified in the Price List.

Exceptions to the above rules apply to items including tyres and pet food. If you are sending tyres or pet food, please refer to the separate regulations for these type of items, in section 3, Permitted Goods,

Example



Packaging example - the parcel was properly secured from the outside, but due to the lack of an external cardboard box, it will be classified as a non-standard parcel.



Security available at home

Packaging example - the package is not properly secured, during the transport process the individual parts may become separated. Due to the lack of an external cardboard box. it will be classified as a nonstandard package.

TIP: Your parcel has a long journey ahead of it. It will be sorted, stacked, transported - this means that products exposed to shocks must be well protected.



Cosmetics

The transport of cosmetics is permitted in the InPost network, however, additional conditions must be met:

- · cosmetics should be in factory-sealed packaging;
- the whole thing should be protected against spontaneous leakage, in the case of liquid cosmetics - the cap is particularly sensitive. The recommended way of packaging liquid cosmetics is to use flexible, tight bags;
- the transport of aerosols and ADR/LQ goods is prohibited in the InPost network

Remember to check the temperature requirements. During periods of heat and frost, our means of transport and Parcel Lockers are not air-conditioned or heated! It is permissible to transport cosmetics in individual glass packaging, with appropriate protection in accordance with the InPost packaging instructions located in section 2 - packaging shipments using the "box in box" method and in the Liquids section.



Clothes

The transport of clothing does not involve additional packaging requirements. It is important to ensure that the size of the packaging is adapted to the volume of the transported goods - this will avoid a situation in which the cardboard box will deform or crack.



Imitation jewellery

Costume jewellery is permitted for transport.:

- · steel and surgical steel jewellery
- copper jewellery
- · beaded jewellery
- · ethnic jewellery and artistic jewellery
- cufflinks made of plastic
- · products made of plastic (brooches, bracelets, pins, chains, etc.)
- devotional items
- · products containing synthetic stones
- · products made of string or strap

The packaging should be tightly filled (bubble wrap, paper, polystyrene) to limit the movement of individual packages inside, in accordance with the InPost packaging instructions in section 2. "Packing shipments".



Electronics, Household appliances & RTV

Articles from the Electronics, Household Appliances, RTV category should be protected from shocks during transport of the packaging. The recommended packaging method is to maintain a distance of 2-5 cm - using filler - between the product and the outer packaging and the vill reduce the risk of damage to the commercial packaging and the product. In the case of shipping goods in commercial packaging, we recommend using a minimum of stretch film as protection against damage to the outer cardboard box. In the case of larger and heavier products, the best way to provide internal protection is to use polystyrene.



Televisions & monitors

The transport of televisions and monitors with dimensions above 28 inches is prohibited in the InPost network. Smaller monitors and televisions should be packed in a cardboard box of appropriate strength, recommended filling: polystyrene.



Furniture

Transported furniture should be disassembled. Individual furniture elements should be separated with dividers. Furniture elements should be secured with a sheet of polyurethane foam, corners covered with polyurethane angles (thickness 3-4 cm) - the whole packed in at least three-layer hard cardboard with a density of at least approx. 800 g/m2 secured with adhesive tape or binding tape.



Sharp objects

It is permitted to transport sharp objects provided they are properly packaged. This type of assortment must be packed using the Cardboard in Cardboard method (**after securing the blade with a cardboard clamp** - instructions for proper packaging can be found on page 9) or if the manufacturer has packed the item in a blister, an additional external cardboard packaging should be used. All items that are weapons in accordance with generally applicable legal regulations, including the Act of May 21, 1999 on Weapons and Ammunition, weapons, ammunition and other explosive or flammable materials (including weapons within the meaning of Art. 4 sec. 1 of the Act of May 21, 1999 on Weapons and Ammunition) are excluded from transport.



Foodstuffs. Dietary supplements

The transport of perishable goods, goods requiring controlled temperature and/or special storage and transport conditions is prohibited in the InPost network. Other goods are accepted without additional conditions, except for liquid goods provided they are properly secured (see page 14).



Medicinal products. Medical devices

The transport of medicinal products is prohibited in the InPost network. The exception is the transport of products classified in class I (including orthopedic collars, examination gloves, products with a measuring function, sterile products).



Alcohols

Alcohols are permitted for transport for Business Customers based on a separate agreement - if you are interested in sending this type of assortment, please visit: https://inpost.pl/en/smartcourier-offer



Grains and seeds

The transport of seeds and grains is permitted provided they are properly packaged (see page 8) and do not require special transport conditions, e.g. controlled temperature.



Advertising and printing materials

It is permissible to use wrapping paper as external protection, but the appropriate number of layers should be considered depending on the weight of the shipment. If wrapping paper is used, the corners of the shipment should be protected with cardboard corners. Advertising and printing materials weighing more than 10 kg should be bound with at least two perpendicular plastic tapes.



Containers for transporting gases, fuels and related

Only brand new products may be transported.

<mark>€=3</mark> Pet Food

Transporting dry granulated pet food in bags is permitted. Additional protection (transparent stretch film) and securing tape are recommended - depending on the weight of the product. This will prevent the product from spilling out in the event of a rupture of the primary packaging.

Transporting dry granulated pet food in a bag up to 20 kg is an exception to the definition of a Non-Standard Package, provided that the method of packaging allows for visual confirmation of the contents. Products above this weight should be packed in a carton.



Hemp products

The transport of hemp and hemp products is prohibited in the InPost network - with the exception of hemp (cannabis sativa sativa) and hemp products derived from it (including hemp fibre products), for which the THC concentration level is below 0.30%.



Tyres

Tyres should be packed in foil or another type of packaging material; stretch foil may also be used.

The maximum number of tyres included in one package is 2 pieces, up to a tyre size of 15 inches, without rims. This type of set should be connected (stretched and bound/taped) in a way that prevents them from separating.

Tyres with rims and tyres larger than 15 inches should be shipped individually. The maximum permissible tyre size is 20 inches, taking into account the maximum dimensions for individual InPost services.

Tyres without rims up to size 15 inches, shipped without a box, are an exception to the definition of a Non-Standard Package.

*The table on the right contains additional information on InPost's handling of shipments containing tyres.



Car parts, mechanical devices

Metal items must have sharp edges protected so as not to damage other shipments.

The transport of car parts that are dry and free from operating fluids is permitted.

Liquids

It is permitted to transport liquids from the household chemicals and construction chemicals categories, provided they are properly packaged (see page 8). Secure the bottle cap against unscrewing and leakage using tape or foil, as shown in figures a, b, c and d.

The total volume of liquids shipped may not exceed 5 litres per parcel.

REMEMBER:

The SENDER should verify the following sections:

"PROHIBITED ITEMS" and "PROHIBITED SUBSTANCES"

to check whether the shipped product is accepted in the InPost network.

Batteries

It is permitted to transport batteries that form an integral part of a piece of equipment (toy cars, scooters and similar equipment).

It is permitted to transport cells/batteries that fulfill the conditions of the special provision PS 188 of the ADR agreement and do not exceed the values specified below:

- For a cell containing metal lithium or lithium alloys, lithium content does not exceed 1g, whereas for a lithium-ion cell, the energy storage capacity does not exceed 20 Wh
- For a battery containing metal lithium or lithium alloys, total lithium content does not exceed 2g, whereas for a lithium-ion battery, the energy storage capacity does not exceed 100 Wh

04 PROHIBITED GOODS

Sinks, washbasins, compact toilets and toilet bowls

It is prohibited to transport the following in the InPost network: sinks, washbasins, compact toilets and toilet bowls that require special conditions during transport and sorting (in particular those made of ceramics, granite and fragranite, those that are fragile, brittle).



Glassware

It is prohibited to transport glassware and ceramics in the InPost network except for cosmetic products provisions.



Tobacco products, e-cigarettes

It is prohibited to transport tobacco products and e-cigarettes in the InPost network.



Stones and coal

It is prohibited to transport aggregate e.g. stones, coal and similar materials in the InPost network.

Construction materials

It is prohibited to transport construction materials: bricks, paving blocks, hollow bricks, lintels, concrete blocks and plasterboard in the InPost network due to their fragility and irregular shapes.



Conditioning oils, paints, wood stains, universal greases, technical greases, impregnating agents, de-fungicides

It is prohibited to transport paints, varnishes, conditioning oils, wood stains, universal greases, technical greases, impregnating agents, de-fungicides in the InPost network.



Drugs, psychotropic and psychoactive substances, the so-called "boosters"

It is prohibited to transport drugs, psychotropic and psychoactive substances, the so-called "boosters" in the InPost network.



Weapons and ammunition

It is prohibited to transport the following in the InPost network: weapons that require a permit, registration or registration card in order to be purchased and possessed in line with the provisions in force, including the Weapons, Ammunitions and other Explosives or Flammables Act of 21 May 1999 (including weapons within the meaning of Art. 4 (1) of the Weapons and Ammunitions Act of 21 May 1999 excluding: bang pistols, starter pistols and alarm guns as well as ammunitions for such guns, provided these are not firearms within the meaning of this act and provided that the Sender provides the Operator with the documents required by the Act and meets the remaining conditions of such service before shipment. It is prohibited to transport ammunitions, except for bang ammunitions calibre up to 6 mm.



Fire extinguishers

It is prohibited to transport fire extinguishers subject to ADR/LQ regulations in the InPost network.



Automotive oils, brake fluids and similar

It is prohibited to transport automotive oils, brake fluids, oil and fuel additives and similar goods in the InPost network.



Batteries

It is prohibited to transport the following in the InPost network:

- · car batteries
- gel batteries, wet cell batteries, maintenance free batteries e.g. AGM, VRLA type.
- lithium-ion batteries/cells* (including those in the equipment)
- lithium-metal batteries/cells* (including those in the equipment)
- other batteries/cells subject to the ADR agreement

*Detailed information on the transport of cells and batteries can be found in the table on page 15.





Aerosols

It is prohibited to transport any aerosols in the InPost network.



Products with a strong fragrance

It is prohibited to transport products with a strong fragrance in the InPost network.



Other mechanical parts and subassemblies

It is prohibited to transport propulsion elements and assemblies that are not secured against leakage of operating fluids – operating fluids must be removed before shipment. Car windscreens, towing hooks, bodywork components and car parts of non-standard shape (bumpers, exhaust systems) are prohibited in the InPost network.



Valuable items

It is prohibited to transport money, securities, other payment instruments and valuable items (jewellery products, works of art, antiques, collectable coins, etc.) in the InPost network.



Animals, plants and biological materials

It is prohibited to transport live and dead animals and plants, including insects and live fishing baits in the InPost network.

It is prohibited to transport hazardous biological materials in the InPost network, including:

- human corpses,
