- ***Politically exposed persons** (PEP) is, with the exception of groups of middle and lower-level positions, persons occupying significant public positions or performing significant public functions, including:
- a) heads of state, heads of government, ministers, deputy ministers and secretaries of state,
- b) members of the parliament or of similar legislative bodies,
- c) members of the governing bodies of political parties,
- d) members of supreme courts, of constitutional courts or of other high-level judicial bodies whose decisions are not subject to further appeal, except in exceptional circumstances,
- e) members of courts of auditors or of the boards of central banks,
- f) ambassadors, chargés d'affaires and high-ranking officers in the armed forces,
- g) members of administrative, management or supervisory bodies of state-owned enterprises, companies with Treasury shareholding, in which more than a half of the stocks or shares belongs to the State Treasury or others, public legal persons,
- h) directors, deputy directors and members of the international organisation's governing bodies or equivalent functions in these organizations,
